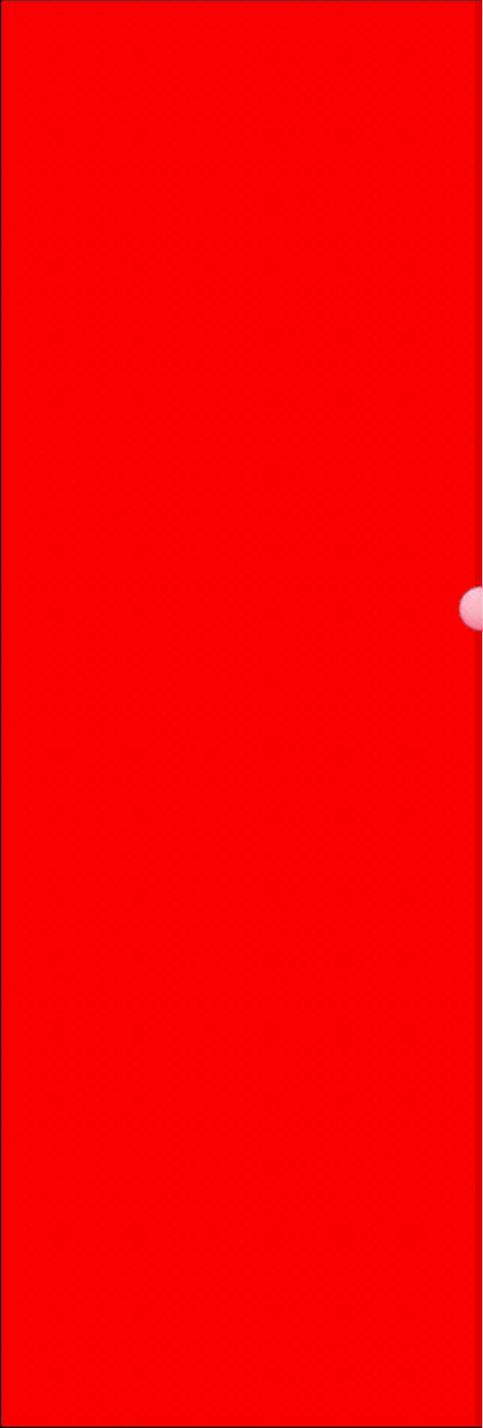

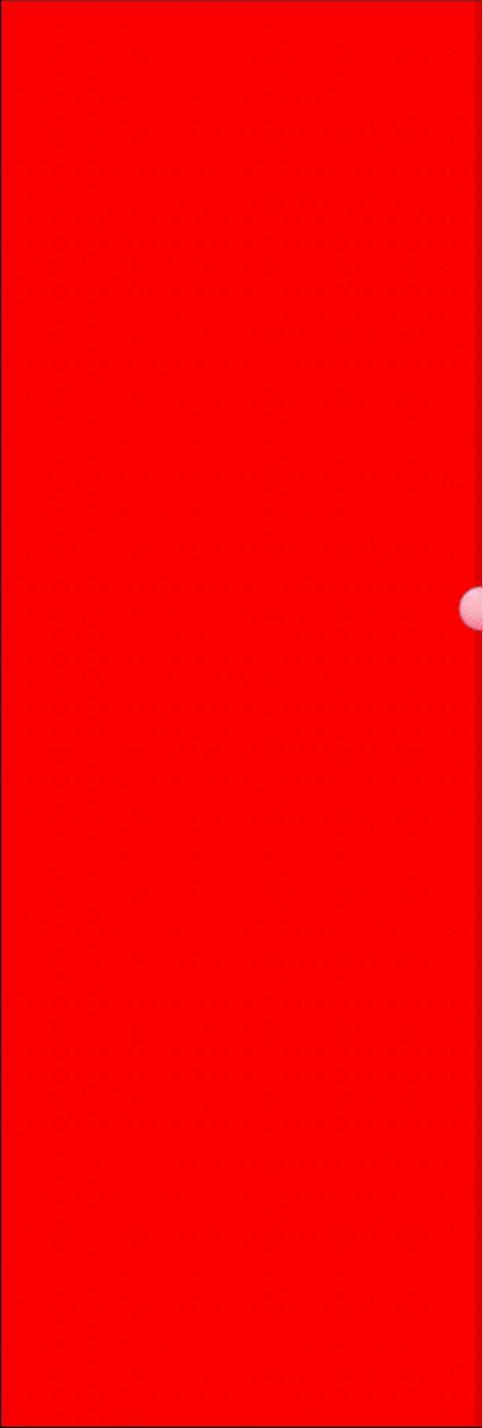

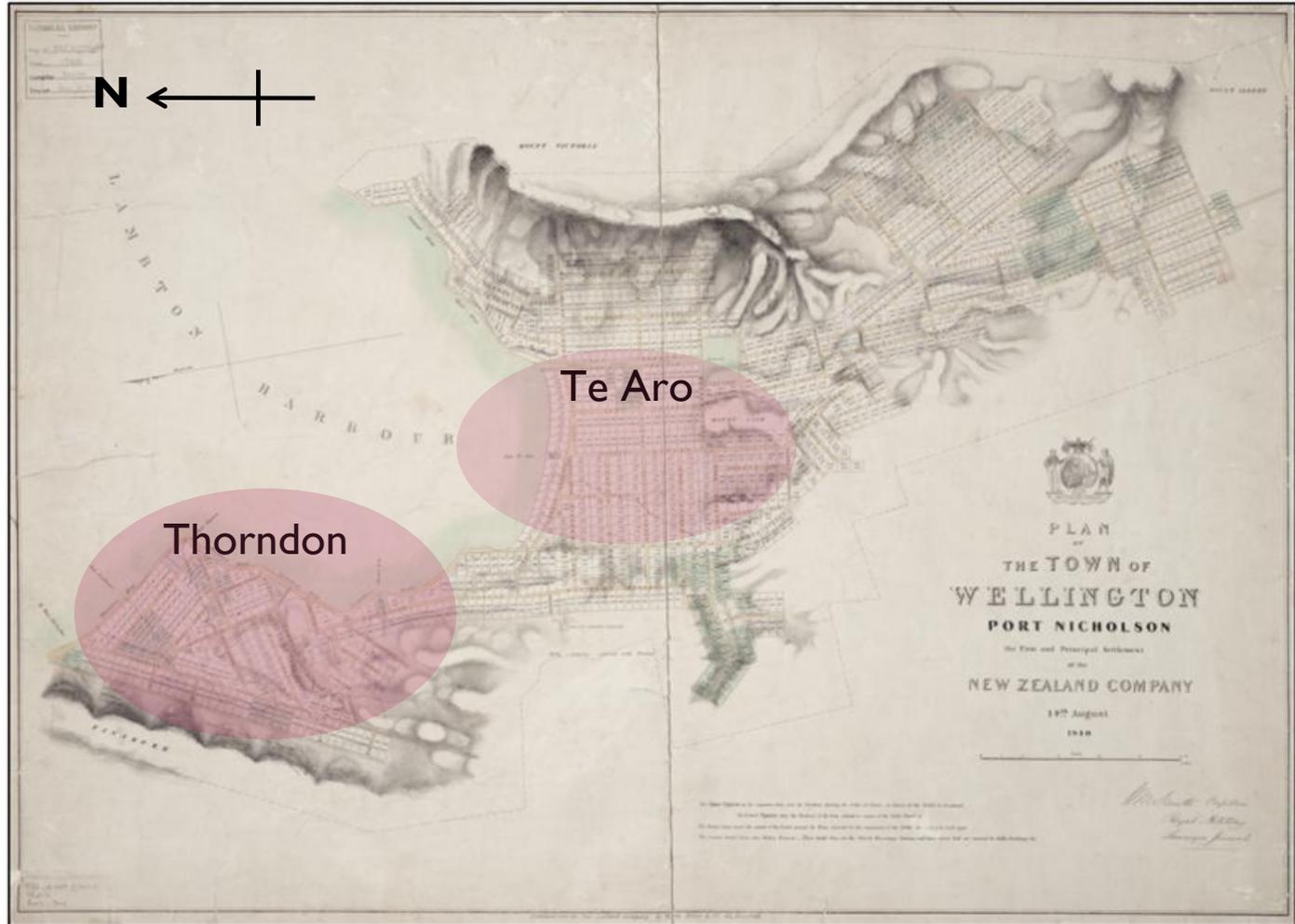
# Industrial and post-industrial cities

- Industrialisation led land use changes in cities during C19th and early C20th
- Post-industrial changes impacted on built environment
- Last 20-30 years people have returned to inner cities
- At same time gentrification evolving to include new-build developments
- All the above are evident in Wellington

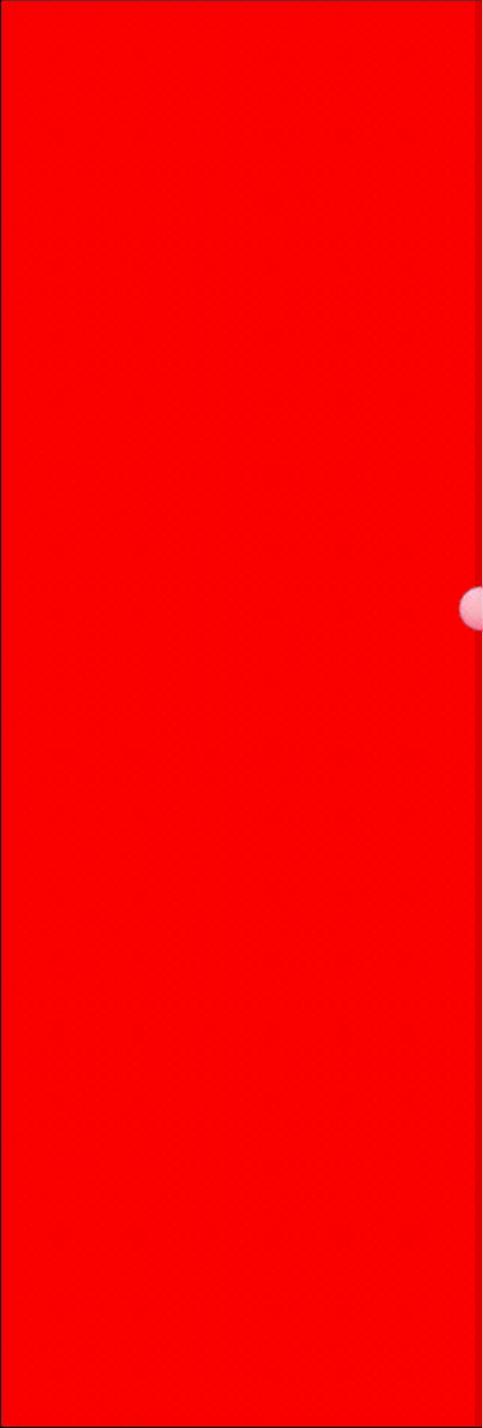

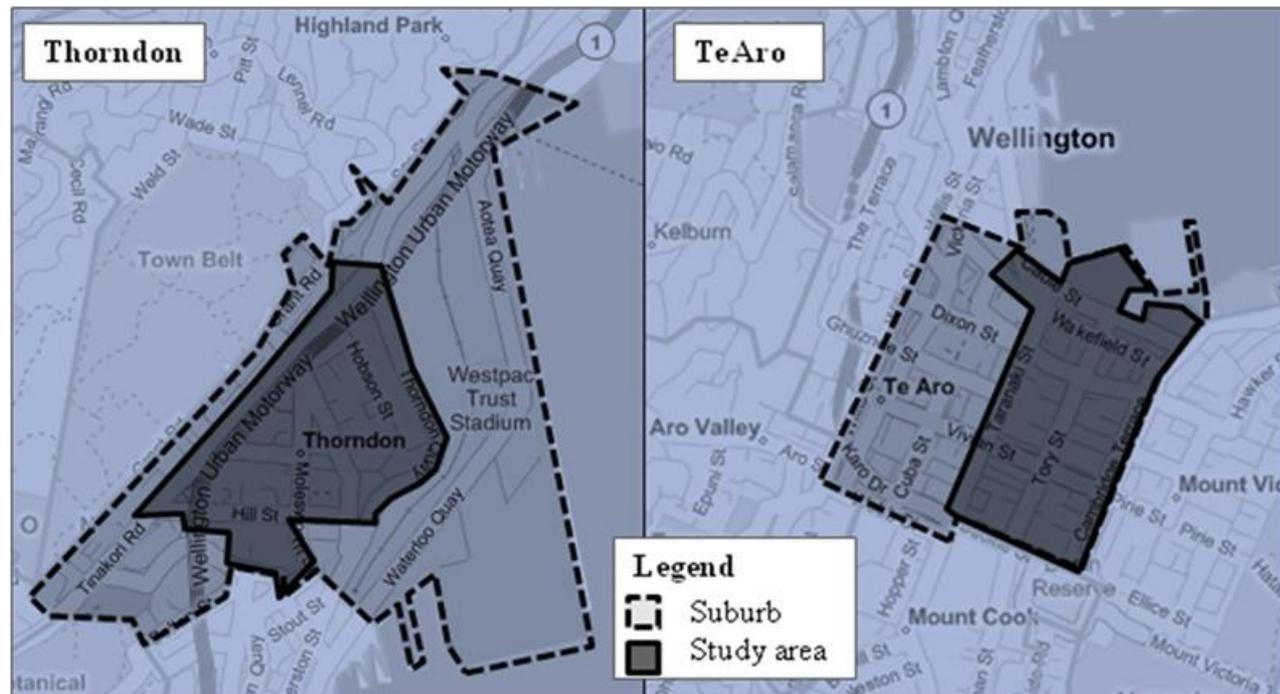

# Locations

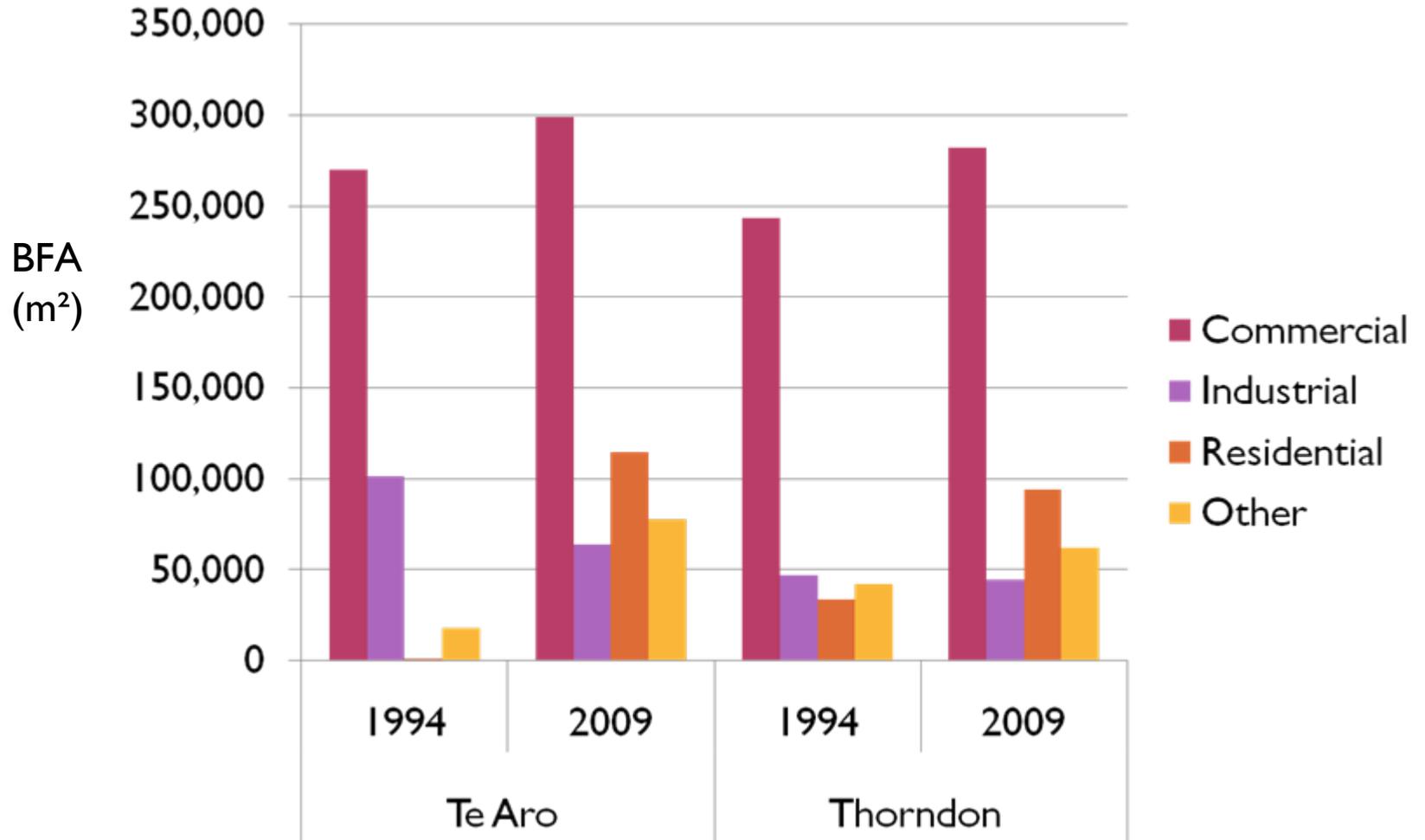
- 28 conjoined meshblocks in Thorndon
- 25 meshblocks in Te Aro



# Data

- Annual property ratings data (1994-2009)
- Properties broadly classified by type:
  - I. Commercial
  - II. Industrial
  - III. Residential
  - IV. Other
- At meshblock level, data includes:
  - I. Number of properties
  - II. Land area occupied by property type
  - III. Building area occupied by property type

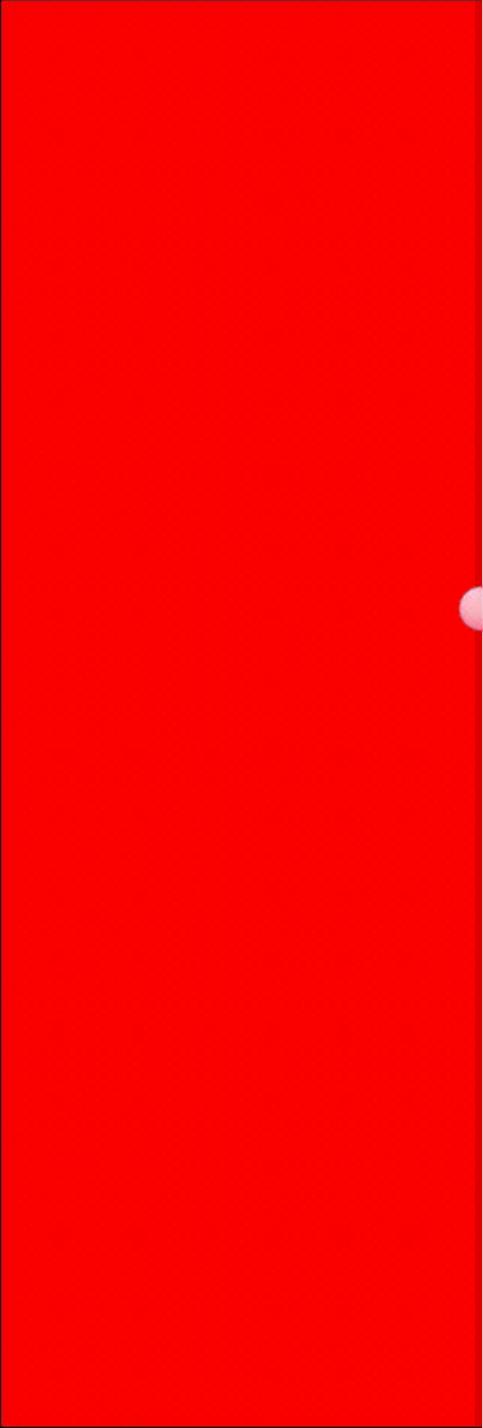

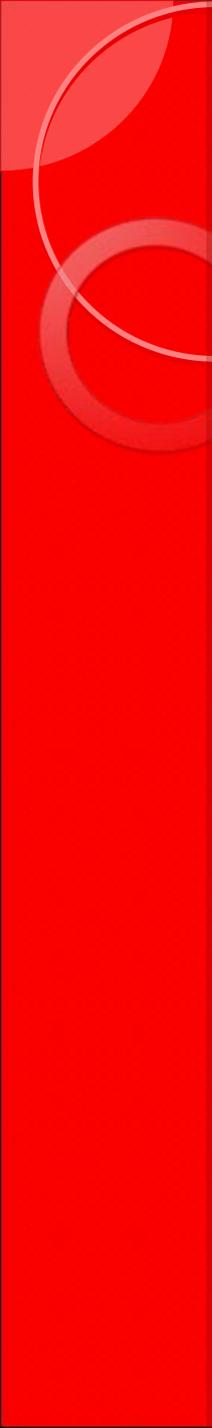

# Summary of results

- More residences with new build mainly medium/high density housing
- Industry (esp. warehouses) vacating inner city
- In Te Aro residential is now second highest BFA after commercial
- Office BFA in Thorndon up by 1/3; while in Te Aro down by 1/4

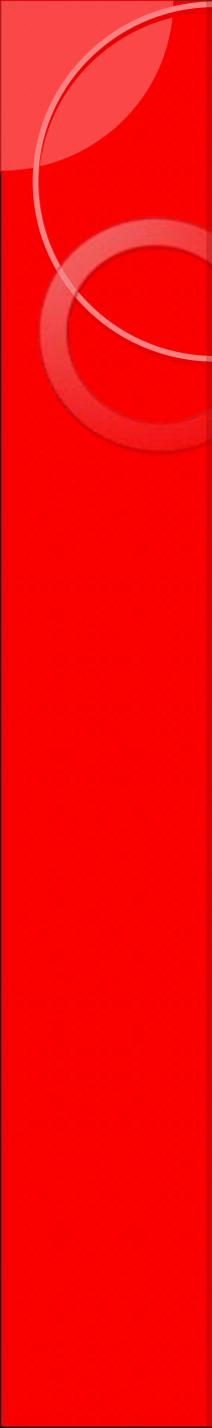

# Wellington: A city in transformation

- Similar to other world cities
- Changes due to a range of state, economic and social processes:
  - Local and central government policies & priorities
  - Commercial and property interests
  - People's preferences
  - Social trends (including gentrification)
- Changes are not uniform
- Reflect early development decisions and distinctive history of each place

# Why are changes important?

- Significant & non-uniform changes can occur quickly
- Further swift transformations possible
- Changes to fuel prices/availability may stimulate these processes
- Leading to greater demand for inner city living and higher density housing
